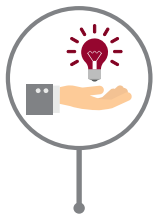

Branch registration implies that a foreign-based company registers its branch in Cyprus, and there is no need to incorporate the local business. The branch must abide by the Cypriot laws and pay taxes in Cyprus. In Cyprus, a branch is not regarded as a separate legal entity, although it belongs to the 'parent' company.
